	<p>CHDEV 56B DE Addendum – was missing frequency of contact information. Christine identified a course, 248OK that has in its outline the same data in the forms that were missing in 56B that she would like to duplicate into the 56B addendum. We approved the course PENDING modification of the Education Contact information section.</p> <p>DEACTIVATIONS: The proposals list incorrectly listed BIOSC 31 and BIOSC 60 as deactivations. These needed to be taken off the proposals list for deactivations (they were approved as Course Change In Catalog – see above). The BIOLOGY courses and ENVSC courses are being deactivated as part of curriculum updating, and are not part of a program. The committee approved deactivation of these courses by consensus. CHDEV 091B was also deactivated by consensus.</p>	<p>CHDEV 56B DE Addendum approved PENDING completion of the fields as described to the committee by Christine (from the other outline).</p> <p>Deactivations approved by consensus, with the exception of two courses (BIOSC 31 and 60) that were incorrectly listed in the deactivations section of the CIC proposals agenda.</p>
<p>Other Topics –</p> <p>Review three-year curriculum review cycle.</p> <p>Revision of programs to show “progression.”</p> <p>Curriculum Institute Check-In</p>	<p>Arja presented a document drafted by Clifton Coleman, displaying a schedule of disciplines for curriculum review. As we are expecting a new VPI and this curriculum review process should have involvement of the VPI, Arja was not certain how soon this process would be implemented. However, some disciplines (BIOL, CHDEV, for example) are already working on updating their courses and certificates.</p> <p>According to the State, our programs must show progression (entry at beginning level, advance to intermediate and complete with mastery) or else they are not real programs. Merritt College has some programs that are just a collection of courses that can be taken in any order. Such programs will need to be revised in order to comply with the definition of a program per the state guidelines. New courses will probably need to be added , to demonstrate progression (beginning, intermediate, advanced).</p> <p>Academic Senate can send two members of the CIC to the Curriculum Institute. Arja has completed her paperwork to request funding from Academic Senate for this conference. Courtney Brown has registered for the conference, but still needs to complete his paperwork and submit to Mario Rivas. Details of the conference were shared with the group: Deadline to register is June 6, 2016 and is located at the DoubleTree Hilton in Anaheim, CA July 7-9 (pre-conference session is optional on July 6). Since the sessions begin early in the morning on July 7 we recommend that you plan your travel so you arrive the evening of the 6th. The Optional pre-session does not have extra cost but you still need to register online to reserve a space. If you plan to attend the optional pre-session then you probably want to plan your travel so that you can attend the workshops (Data Unlocked is 10am-12pm and the afternoon workshops for curriculum chairs, administrators and curriculum specialists run 2-5pm).</p>	<p>Contact Mario Rivas for DAS funding for travel expenses.
