Response to Recommendation #6 self-report</p>	<p>a) Discussion of the larger role SLOAC should play in gathering information from the recent program reviews, especially section 4: “Briefly describe three of the most significant examples of your discipline, department or program <u>plans for course and /or program level improvement</u> for the next three years as result of what you learned during the assessment process. Please state the data from the “Assessment Findings and Action Plan” section for each example.”</p> <p>b) As part of our work promoting and sustaining assessment, SLOAC should <u>develop a comprehensive table for college-wide innovations based on different assessment data</u>, including SLO/PLO/ILO work but also including other measures of student learning such as program review data and other ways we assess and respond to student need. For example, CHDEV found through assessment in the capstone course that oral communication results were weak; as a result, curriculum was changed to increase oral communication. Another example: DSPS responded to poor student success data for their students in basic skills courses by creating curriculum to prepare students for success. We should ask Audrey how Sankofa came about because it addresses some measure of a need for improved success for African American students.</p> <p>c) Laura H: Sankofa was a response to student surveys as well.
