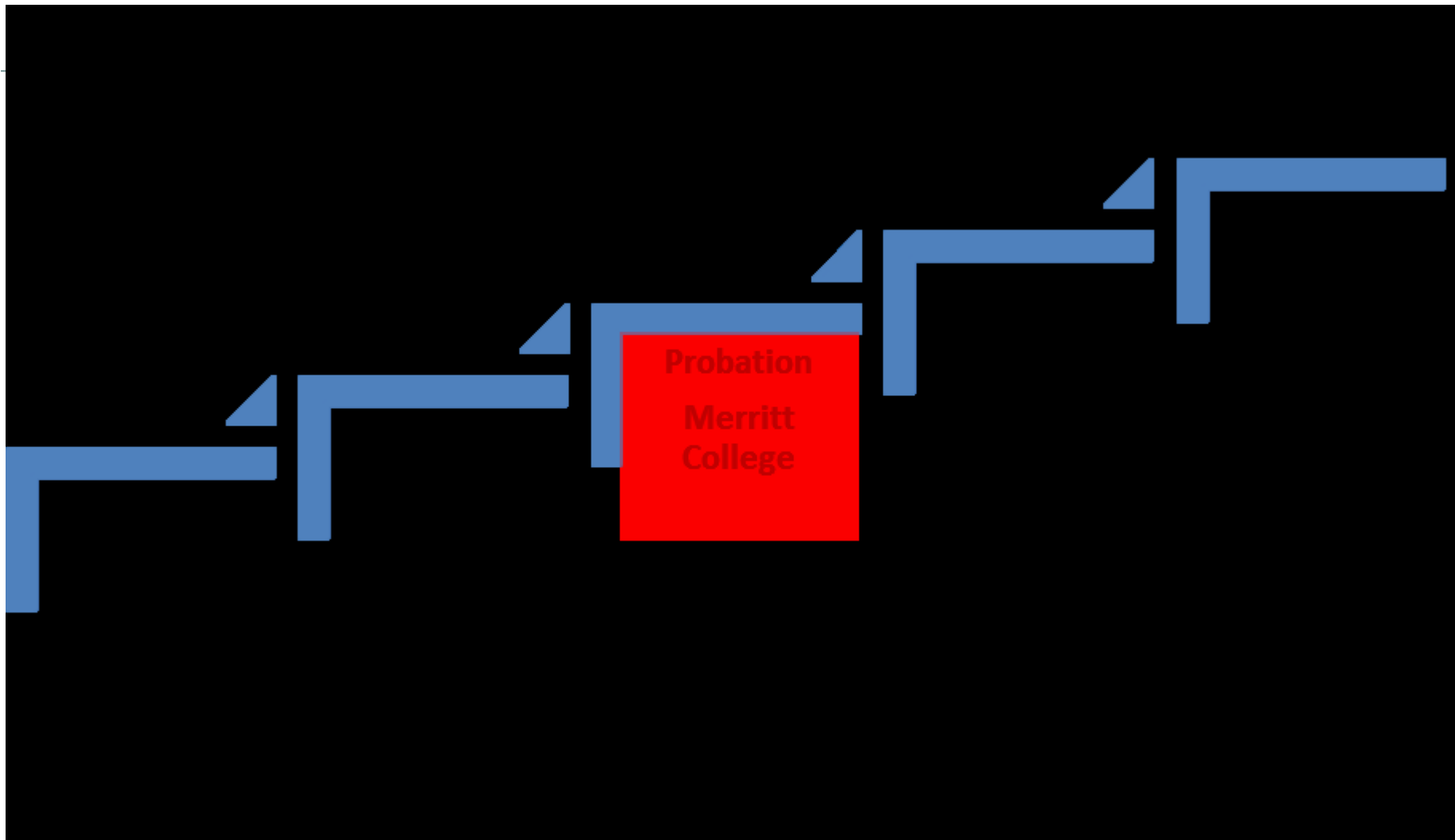

## Nine College Recommendations



- **Sub-Committee Team Progress Reports (2 Minutes Each)**
  - What have you learned?
  - Obstacles encountered?
  - Help needed?



# Accreditation Follow-Up Report Strategies for Goal Achievement



- **CONDUCT A GAP ANALYSIS**
  - Merritt College Self Evaluation Report
  - External Evaluation Report, May 8, 2015
  - ACCJC Standards (Out of Compliance Deficiencies)
  - What if the gap analysis reveals the need to start over?



# Accreditation Follow-Up Report Strategies for Goal Achievement



- **Where can I find the information needed to show how the College meets the Standards?**
  - Utilize the Administrative Support Liaison
    - Identify sources of information
    - Clarify institutional processes and policies
- **Access Shared Governance Committee By-Laws and Archives**



# Accreditation Follow-Up Report Strategies for Goal Achievement



- **What if information on institutional processes and policies is incomplete or unavailable?**
  - Co-Leads should notify the administration and/or Shared Governance Committees of recommended corrective measures and initiatives
  - Sub-Committee should recommend corrective actions or measures in the written narrative, including timeline for implementation





# Accreditation Follow-Up Report Strategies for Goal Achievement



- **Looking at Evidence**
  - Utilize ACCJC Sources of Evidence
  - How should I use evidence to support the College Recommendation written narrative response?
