3. Review of CEMPC bylaws and mission statement process	Grampp presented a proposal for a new 10 Step Mission Statement approval process. Vasconcellos suggested the process be tied to EMP (Educational Master Plan). Vasconcellos suggested that the Vision Statement also be updated and suggested that there be a Task Force to lead the process which reviews the Mission and Vision Statements. Rivas suggested that we add a narrative that states that CEMPC initiates Mission and Vision Statement, after the revision of EMP. CEMPC suggested adding another survey (step 1 and step 4.5). President reminded CEMPC the suggested motions would require CEMPC to be responsible for these tasks. Grampp expressed the importance of taking minutes and updating bylaws to reflect the Mission Statements.	Cedillo Motioned to accept the process that Grampp has presented with some minor corrections. It will be on the 5-year cycle and in conjunction the CEMPC bylaws will be updated to reflect the new Mission Statement process. 6. Joint Meeting with CBC and CEMPC	<p>Del Rosario explained the purpose of the joint meeting is for all shared governance constituents, Vice Presidents and President and Business Services Manager to review the resource request list. A finalized resource request list is due to the district before March 18, 2016. Resource requests are tied to program reviews and SLO assessment.</p> <p>President Ambriz-Galaviz shared the Resource Request List (which was extracted from all Program Review requests). CEMPC requested clarification, specifically how each request was linked to SLO assessment and learning. Vasconcellos confirmed that the Division Deans are reviewing the requests and making sure the requests are reflected in their Program Reviews. Kessler suggested creating a prioritized resource request list, which allows us to create a check off list. The check off list will allow us to create a check list of what was completed.</p> <p>CEMPC noted the need for clarification of resource requests documented in program review versus resources from discretionary funds. President Ambriz-Galaviz noted the program review drafts 3 year goals for the program and resource requests needed to fulfill these goals.</p> <p>CEMPC reviewed the District and College deadlines for the Resource Request List. PBC meets next Friday (March 18) and College Council meets next Wednesday (March 16). The committee discussed the shared governance process. Kessler suggested aligning goals with budget.</p> <p>Everything should be listed and prioritized. Prioritization will be based upon the needs or goals of the college or program. All departments on the list. The list will be presented at the joint CBC and CEMPC meeting.</p>	<p>The joint meeting will be held Tuesday, March 15, 2016, 1:30 PM.</p> <p>The Technology and Facilities Committee will be invited to attend the joint meeting.</p>
