# Meet the Accreditation Follow-Up Report (AFR) Core Team





**Dr. Audrey Totter, Chair,** has 35 years of diverse experiences in community colleges, Dr. Trotter has served as a faculty member in Education and Learning Resources at Merritt College and Director of the Learning Center since 2003, Title III Grant Project Director from 2008 to 2014, with service in the Peralta Community College District since 1999. Accreditation Experience includes: Accreditation Liaison Officer (ALO) at two Peralta Colleges; Lead Community College Self Evaluation Report, Mid Term Progress Report, Follow-Up Report Teams and Processes and service on four ACCJC Accreditation Evaluation Teams. Dr. Trotter has been a representative of the Academic Senate since 2007 serving as Treasurer and more recently as Vice President. She has also served as President of the College Council and Chair of the Professional Development Committee.

**Dr. Mia Kelly, Co-Chair** is the Tenure Review Facilitator for new hires on the tenure track.
