Good morning, Merritt Community.

Late yesterday I received the letter below and attached from the Accrediting Commission. The news is bittersweet. Merritt College has been removed from "Probation" and elevated to "Warning" and "granted a good cause extension". We are required to submit a Follow-Up Report along with a Midterm Report. The Follow-Up Report is due in October 2017 and followed by a visit from the Commission. The reason for Merritt College being moved to warning rather than reaffirmation is that "the College is in the process of addressing College Recommendation 6, but has not yet achieved compliance...and must "accelerate the identification and documentation of student learning outcomes for all courses, programs, certificates and degrees, and to assess student attainment of those outcomes to ensure that all of its instructional courses and programs are of high quality and to make improvements."

Next steps are forthcoming.
