At the request of the President and Vice President, some SLOAC members are working this summer to complete PLO (program learning outcomes) assessment on campus and strengthen our response to the accreditation sanctions. Through this, I'm reviewing programs that have not completed assessment in this three-year cycle. One is the AA in Liberal Arts with Emphasis in Cross Cultural Studies.
