**VP Hogan:** Reported that 12<sup>th</sup> grade students from Sojourner Truth Independent Study are having difficulties in accessing online education and that the ASMC Inc.

could devote resources to training these students to access online education materials to build institutional relationships and recruit students to enroll at Merritt.
