### Written Update to College Council for February 26, 2014 Meeting

#### Meeting Date: Tuesday February 4, 2014 CFC and Friday February 7, 2014 DFC Committee: Facilities Submitted by: Brock Drazen

Please reference below updates:

- Dean Stacy Thompson attended the CFC and noted the poor condition of the 'grassy knoll' graduation area between buildings D and E/F. Her Kid's College summer camp uses that area and asked that the committee discuss solutions. One suggestion was to re-sod the area
- The committee reviewed each and every faculty and staff submission after the December email request regarding campus repair needs. Each submission was categorized and committee members added additional repair needs that they were aware of. The committee correctly anticipated the district would request a list at some point in the spring. These faculty and staff submissions were included on a master list of emergency repairs submitted to the district by the February 21, 2014 deadline. The master list of prioritized emergency repairs is included with this report.
- The committee continues seeking it's school year long request for an infrastructure report from engineering either at the district level or from a campus representative. While faculty, staff and administrators are diligent in reporting visible repair needs, there remain unseen deeper campus repair needs that are likely costlier to repair and more significant for the long term maintenance of a safe, efficient and operational physical plant.
- At the district facilities meeting, a long presentation regarding electric vehicle charging stations was delivered by sustainability professionals in that field. Five charging stations each with the capability of charging two cars (10 parking spaces) will be installed at Merritt in the near future and must be installed by March 31 to take advantage of credits and rebates.



### **CDCPD February Report**

The CDCPD remains focused on completing numerous faculty responsibilities including submission of the Summer and Fall 2014 schedules. In addition, we need to continue to meet our contractual obligation for evaluating part-time and tenured faculty. Also, we need to keep up with our responsibility to assess student outcomes in Taskstream along with reviewing and updating courses in CNET (which must be done every five years). While making progress, there remain too many places where these things are not happening.

We are evaluating restructuring one department, splitting it into two separate departments and will update one discipline name change, from PE to Kinesiology. Additional attention must be given to enrollment strategies and planning that address the needs of the broader community including those who currently do not find class times attainable for their personal circumstances.
