- 3. You must provide a written justification to support your petition. You should attach any supporting documentation that will support your petition. If you are challenging an English course prerequisite, you should attach a sample of your written work. Incomplete petitions will be denied.
- 4. Once you have completed the petition and attached your supporting justification/documentation, submit the form to the Admissions and Records Office. Admissions staff will enroll you in the course. The form will then be submitted to the Department Chair for their review. A challenge will be resolved by the appropriate staff within five (5) working days. You will only be notified if your petition is denied.
